



# WIRE CONTRIBUTIONS TO TRF OR TRF (CANADA) FOR USA & CANADA

We want to ensure that your contribution is directed as you intend. Along with sending your wire donation, please submit the contribution form. With wire payments, payments details sometimes don't transfer completely, so it's important that we receive this critical information on the contribution form. Otherwise, your donation could possibly be misdirected to the World Fund, the donor/recipient may be recorded incorrectly, or Foundation grant projects may be delayed.

## 1. Give your bank all required wire transfer information to complete the wire.

See the wire transfer details below for your country. Make sure that your bank enters the beneficiary details (grant number/donor number/designation) in the payment remittance field.

- Donor's name
- Donor's number
- Name of recipient and if Paul Harris Fellow (PHF) recognition is required
- Designation of contribution (tracked gift number, if applicable)
- Approved Foundation Matching Grant or global grant number (if applicable)
- Purpose of the donation
- Date the wire was issued by the bank
